* In accordance with the Americans with Disabilities Act and our desire to have our meetings open to everyone in our community, Council meetings are held at the Chevy Chase United Methodist Church which has handicapped elevator access via the parking lot entrance. We are grateful to the Church for their generosity in allowing us to use their facility each month.



Section 3 was hit with a significant snowstorm. Snow Central did its best to

clear streets. We appreciate how promptly residents moved cars into driveways, making snow clearing much easier. The first snowfall was challenging, but most people took heed and moved vehicles with the second snowfall.

Snow Central obtains its salt from the State Highway administration through a Memorandum of Understanding we have with the state. The salt depot is conveniently on the ramp of Connecticut Avenue and the beltway; this year, however, it hasn't been consistently open, making it very difficult for our contractor to obtain salt once the storm ceased.

So that we are not caught short-handed again, the Village Manager has arranged with Montgomery County to obtain salt from their depot on Brookville Road near Lytonsville in Silver Spring. Section 3 will now have two sources of salt so we will not be caught without.

We have over 80 locations where we shovel seniors' homes (including many corner properties) so it took a team of nine shovelers five and a half hours to clear sidewalks, but they did it. Many thanks to all those who helped out a neighbor and thanks to all of you who did not have to be reminded that it is a Section 3 ordinance that snow must be cleared from the public sidewalk within 12 hours of the cessation of a storm.

The Council met in person and via Zoom on Wednesday, January 10, 2024, with Council members Ellie Nader, Tom Carroll and Katy Vale present. Council Chair Susan Manning and Vice Chair Larry Lanpher were absent. The meeting began at 7:52 p.m.

The minutes from the December meeting as published in the January newsletter were approved.

BUILDINGS & ROADS

The Village Manager, acting as the Permit Services
Coordinator, gave a status report on all building activity in the
community. She reported that a permit was issued for the demolition of an old deck at 3616 Raymond Street for the **Landau** family.
A permit for a shed was issued to the **Allen** Family at 3609 Taylor
Street.

Permits are pending for a basement dig-out at 3623 Raymond Street and a fence at 3606 Taylor Street. We are waiting to hear if the County has granted a permit extension for 6803 Georgia Street. No work is currently ongoing at the site. The Village Manager had made inquiries but did not receive a response. She will try again.

On-going work continues at 6809 Connecticut Avenue on the deck. At 6806 Delaware Street. a permit has been issued but work has not commenced. 6705 Georgia Street should be finished by May/June at the latest. Work at 3616 Raymond Street on a rear door and a new deck is ongoing. And at 3624 Raymond Street, there is ongoing interior work which should be finished by April/May. Work at 6808 Florida Street. may have to wait until spring as much of it is exterior work.

Montgomery County is looking into the violation of the zoning code at 7009 Connecticut Avenue by the contractor who renovated the home and paved over the whole front yard.

3706 Spring Street construction is complete; the house is on the market.

The Village Manager reported that at a virtual meeting took place with members of our state delegation to Annapolis and County Council President and Vice President Kate Stewart. They advised that this legislative session would not be good to push for a change in the state law to make all municipalities in Montgomery County without zoning authority responsible for setbacks, height and massing for "residential" housing instead of all "single family" housing. An Attorney General's opinion states that it is understood that municipalities without zoning authority would be able to regulate the same restrictions that they do now for multi-family as well PAGE 2

as single family homes.

The Council discussed the proposed ban on gas powered leaf blowers ahead of the County ban in July 2025 and voted not to adopt a ban ahead of the County's announced restrictions (see story this issue).

In January 2023, the Council agreed to determine if the thennew Boundary Survey Grant Program was worth continuing after a year. The program has only been used once, but it was helpful to the family who used it, and it met the goals set out by the original program. The Council unanimously agreed to continue the program for which a little less than \$10,000 remains in the budget.

FINANCIAL & ADMINISTRATIVE

None of the Councilmembers raised any questions about the financial reports they received prior to the Council meeting.

The Council endorsed the idea of renting offices on Brookville Road above the Olympia Café. Although terms need to be finalized, the rent for two offices is expected to be approximately \$1,000 a month plus utilities. The estimated cost of building out the space is expected to be a few thousand dollars. The Council agreed to have the Village Manager proceed to negotiate with the landlord and arrange for the space to be improved. Most of the smaller municipalities now have rented office space. Martin's Additions' office is a few doors down on Brookville Road. Chevy Chase View has rented office space in Kensington and all our other neighbors, with the exception of Section 5, have rented offices instead of home offices.

A resident complained that the sign directing people visiting the Farmers Market constantly falls over and the Village Manager agreed to get another more stable sign holder, perhaps an easel style to put in its place.

COMMUNITY & SOCIAL

The January drive for laundry detergents, feminine hygiene products for needy families ends Sunday, January 28. Donations should be left at the home of the Dorsey/Williams family.

The executive session to evaluate the Village Manager's Salary and performance has been postponed until the February meeting when the full Council will be present.

The meeting adjourned at 8:17 p.m.



NEIGHBORHOOD NEWS


Ezra Shapiro began attending Montgomery College last fall in its Graduate Transition Program. His brother **Avram** has been accepted to Williams College for fall of 2024.

GAS POWERED LEAF BLOWERS DISCOURAGED, NOT BANNED

After much consideration, the Council voted not to adopt the resolution banning gas powered leaf blowers a year ahead of the Montgomery County ban.

The Council agreed to encourage residents to limit gas leaf blower clean up in the period leading up to the County-wide ban in July 2025 to no more than once in the spring and once in the fall at most.

The Council felt that many contractors who work in neighboring communities where a ban now exists will use electric or battery powered blowers and that since we asked people to inform their contractors to refrain from using gas blowers for normal cosmetic cleanups each week that the noise levels had significantly dropped. Council Vice Chair Larry Lanpher asked that his views be read at the meeting saying: "If I were present at the meeting, I would vote not to adopt the draft Ordinance. I personally hate gas leaf blowers and have prohibited our landscaper from using them on our property.... But I also do not favor ever increasing regulations and given the upcoming County ban on gas leaf blowers, I just do not see the benefits of having a Section 3 ordinance that would be in place for



approximately a year.... I hope that the Council will urge again that residents restrict use to times that are really necessary and not use (or allow their contractors to use) blowers for cosmetic purposes, such as blowing grass clippings from the sidewalks."

Responding to a request for input on this issue, one resident pointed out that our ordinance would require neighbors to report on other neighbors and that was not the way we want people to be treated in Section 3. That concern resonated with the Council and when the vote was taken, the Council unanimously voted down the ban in advance of the County Ban.

The Council made a commitment to advertise and inform residents asking them to make it clear to their contractors, that gas powered leaf blowers are not necessary and if they absolutely needed to clear their yard once in the spring and once in the fall until the County ban became law, that would be the most we wanted in our community. This means a concerted effort on everyone's part, but one we have already seen has had an impact on the frequency of gas blower use in our community. We ask for your cooperation as good neighbors without the threat that two neighbors have to be willing to testify as to the use of these machines and issuing citations and fines to our neighbors.

TAXES TAXES TAXES

The federal and state individual income tax filing deadline is Monday, April 15, 2024.

We need your help to ensure that all income tax revenue due the Village actually gets here. By law, as a municipality, the Village receives a portion of the state taxes you pay. This is Section 3's largest revenue source.

Thus it is important that the State of Maryland knows where to return this revenue. MD Form 502 features a separate political subdivision section located under your mailing address. When completing your Maryland income tax return, remember to put Section 3 of the Village of Chevy Chase under Maryland Political Subdivision and include the 4 digit Political Subdivision Code of 1614 to ensure the Village receives its share of the state income tax.

The Friends of the Chevy Chase Library, a community based non-profit that supports our community library, hosted its first "Shut up and write" session on Wednesday, January 31 at




noon. The program will continue weekly, same time, same place for people who want to have a distraction-free location to write.


DISABILITY INFORMATION AND ACCESS LINE


