ORDINANCE REVISIONS DISCUSSED

The bulk of the 90-minute October Council meeting was spent discussing the draft changes to the ordinances. In addition to the draft revisions, several residents suggested that we include a way to preserve trees, especially on "teardown" properties. Unlike many of our neighboring communities, Section 3 has only recently begun experiencing developers who clear-cut and tear down existing houses. At the suggestion of those attending the meeting, the Council is investigating options to address this concern, which directly affects stormwater, quality of life, and the character of the entire neighborhood. This issue will be discussed further at the November meeting.

The other issue that received a good deal of attention is one area that the Council is considering, but had not drafted a definitive proposal: lot coverage. The challenge in Section 3 is that we have such diverse lot sizes and we need to find a ratio of open space to impervious areas that will preserve the character of the community, retain some much needed greenspace, and allow sufficient area for adequate stormwater runoff. Said Council Chair Susan Manning, "The challenge is finding that sweet spot" that will reflect all our priorities without unduly burdening homeowners. The Council continues to study the issue, hoping to discuss lot coverage again at the November meeting.

All the proposed ordinances will be posted on the website for the community to review. A number of residents have already drafted comments for the Council and the Council welcomes additional feedback. If you are interested, please join the November 11 Council meeting via Zoom, ask for a copy of the current draft ordinances amendments, and let the Council know your thoughts.

The Council met via zoom on Wednesday, October 14. The

primary topic on the agenda was the draft changes proposed to update our ordinances (see story this issue).

This report will focus on the other business that took place during that meeting.

The meeting began at about 7:55 p.m. All Council members, with the exception of **Bill Brownlee** who passed away since the last meeting, were present.

Before beginning the meeting, the Council took a moment to recognize the life and contributions of Council Vice Chair and former Chair Bill Brownlee.

The Council approved the minutes of the September meeting as they appeared in the October newsletter.

PUBLIC SAFETY

Police continue to patrol our streets: working both overnight shifts sometime between midnight to 6:00 a.m. and day shifts.

BUILDINGS & ROADS

Carolyn Greis, head of Buildings and Roads, reported that two permits were issued to construct fences: one to the **Millian-Jest**

family of 3602 Spring Street to build one in their rear yard and one to **Jon Mark Properties, LLC**, to build one in the two front yards at 6822 Delaware Street. The **Dorsey-Williams** family of 3619 Shepherd Street was issued a permit to build a patio in their rear yard, and the **Berkeley** family of 3800 Raymond Street received a permit to install a sump pump. The **Dillon** family of 3801 Bradley Lane received a permit for a temporary storage unit.

Susan Hamburger of 3600 Taylor Street was granted a variance to build a screened porch onto the existing deck in her rear yard which will intrude 3' into the 20' rear setback.

Construction work at 3602 Taylor Street is progressing on schedule. A resident suggested that repairs be made to the sidewalk because its current cracked condition is a dangerous tripping hazard. The Village Manager suggested asking the builder to put in a plywood sidewalk, and it was agreed that the request would be made as soon as possible. The builder has also filled in the ruts in the greenway on Georgia St which still needs sod.

FINANCIAL REPORT

The Village Manager has been working with our auditors; the draft audit is almost complete. After November 1, as soon as the final report is submitted, any resident who wishes to see a copy need only ask the Village Manager.

WILLIAM H. BROWNLEE, 1927-2020

Former Council Chairman Bill Brownlee passed away October 3 at his Shepherd Street home surrounded by his four children. Brownlee stepped down as Council Chair last year to become Vice Chair. He served our community for over 20 years first as head of Buildings and Roads, then as Vice Chair and finally as Chairman.

Born in England 93 years ago, Bill remained a confirmed anglophile his entire life. His late wife Sheila was also from England where they met in 1949. Married in 1953, the couple and had four children, Ian, Gordon, Stephen and Janet.

A graduate of St. Andrew's School in Delaware, Bill went on to Cornell, served during World War II in the US Army, and, after working in his father's family business, went on to work with IBM for a successful 30-year career.

After retiring, Bill began his second career in service to others. In addition to his work in our community, where he and his family lived for nearly 61 years, Bill was a trustee and alumni

board member of St. Andrew's, a trustee of St. Anne's Episcopal School in Delaware, an usher at his church, St. John's in Lafayette Square, and an usher at Roundhouse Theatre.

Bill loved people, walking and rowing. He began rowing at St. Andrews, continued to row at Cornell (class of 1950), at the New York Athletic Club and regularly plied his own single scull on the Potomac until his 92nd year. In 2017 and 2018 he won the World Indoor Rowing Championship in his age class, confiding in the Village Manager that "at my age, there wasn't a lot of competition"—but he bested an 87 year old!

Bill cared deeply about this community, about his neighbors and his family. He will be sorely missed. The Council is in discussions with his family about a suitable way to remember him. Contributions may be made in his memory to St. Andrews School, 350 Noxontown Road, Middletown, DE 19709.

The Section 3 Charter calls for a vacancy to be filled by Council appointment and for that office holder to serve until the next election, which in this case will be in May 2021. The Council will discuss a potential replacement at its November meeting.


