ANNUAL MEETING: THE YEAR IN REVIEW

Donna Harmon and **Jon Newhard** were elected to the Village Council at the annual meeting in May. Each received 27 votes. Following their swearing in, the new Council voted Donna as incoming Secretary and Jon as the Council's new treasurer. All the other Council members kept their positions from last year.

Council Chairman **Bill Brownlee** summed up the key activities of the past year as related to public health and safety, **Natasha Saifee** summarized the many social activities which have taken place in the community. **Mike Shannon** took a moment to welcome our many new neighbors, including a number of new babies in the community and remembered those who recently passed away. **Paul Kiernan** outlined the Village's financial condition and the community approved the budget for next year.

Plans for next year include expanding community activities to bring together more diverse groups of Section 3 residents. Upcoming events include the "Bark at the Park" event slated for Sunday, June 8th for dog owners and would-be pet owners considering adoption through the Humane Society. That same day, in the evening, the annual Wine Tasting event will occur with three gracious residents hosting the event: **the Glynn family, Susan Toffler, and the Murphys** on Raymond Street. Residents will be receiving a brochure describing these events in detail along with a sign-up sheet for the Wine Tasting Event.

Natasha Saifee mentioned an offer by Section 3 Resident and official DC Tour Guide, **Frank Vita**, to set up a special guided bus tour of the Nation's Capital for the enjoyment of Section 3 residents. Parking is often such a problem, but with our own bus it wouldn't be. Plus you can brush up on your appreciation and understanding of some of the many historic sites we have at our fingertips that many of us just don't visit that often. Please contact the Village Manager to express and interest in this event.

Carolyn Greis recounted all the permits issued this year and then discussed next year's plans which include improving the signage in Section 3 following the recommendations of our consulting engineer, Joe Cutro. We'll begin by replacing many of the signs in poor condition or in bad locations with new ones. We'll repaint the yellow curbs throughout the community and then renovate all the street signs to be easier to read, better placed and more distinctive. We are still awaiting approval from the State Highway Department for the sign that would grace the entrance to Section 3 at Bradley Lane and Connecticut Avenue in front of the light control box recently installed on that site. We hope to mill and pave the dead end

COUNTY COUNCIL HOLDS SPENDING INCREASE TO 4.3 PERCENT

The County Council adopted a stringent budget that will hold property tax rates at their current level, offer taxpayers a lower "credit" on their taxes than last year, and expects to make up the deficit through increased assessments, higher energy taxes and other cost cutting measures. The property tax plan proposed by County Executive did not pass. Instead, the County Council agreed to give residents a property tax credit of \$579 (down from \$613 in FY 08) and not raise the property tax. The average assessment on a Section 3 residence is about \$1,125,285.00 for FY 09. Under the adopted plan, that will mean that in FY09 taxpayers with houses of that value will pay approximately \$11,236.49 a year in property taxes. The County Council voted a \$579 "tax credit" but the rate, when you figure in the County and State taxes and Section 3's annual \$.02 per \$100 assessed valuation comes out to about \$1.05 per \$100 assessed valuation, less the \$579 credit. This is better than the proposed \$1.11 per \$100 assessed valuation but it still represents a large increase, particularly considering that most residents were recently re-assessed. Section 3 pays the county landfill charge that appears on all tax bills for every Section 3 resident. While last year's fee was \$29.50, this year's charge has yet to be announced.

For those of you who took the time to write your Council members regarding the larger proposed increase, it's clear that the Council acted with your protests in mind.

On other fronts, the Council did increase the energy tax on your Pepco bill 10 percent and your Washington Gas bill energy tax will go to five percent.



of Delaware Street soon along with milling and paving the area of Fulton and Taylor Streets where the water lines have been replaced.

At the moment, we are having our civil engineer, who assists us with water and drainage issues, evaluate the condition of all the storm drain inlets in Section 3. This has never before been done and, to properly maintain these inlets, it's good to check them to be certain they are in working order. We have also identified concrete repairs that need doing and expect that, within a month to six weeks, we'll have D & F Construction make those repairs. Hopefully, by early summer, all the streets will be in good condition and the signs upgraded as well.

On a more sobering level, at the State and County level, funds for "tax duplication" are in the process of being re-calibrated and it appears that in FY09, Section 3 will receive a significantly lower payment from the County for park maintenance and for other services based on new formulas now being developed by a joint municipal/county task force. Similarly, there is talk that the County may want to ask the state to lower the income tax allocation that goes to all municipalities, which is our largest source of funding for Section 3 activities and responsibilities. This year the state created new tax brackets for those at the higher end of the income scale but that money goes directly to the state, not to the County or any municipalities to help cover the state deficit.

Our reserves may come in handy as the economy slows and income tax revenues are lower than anticipated. Section 3 always budgets conservatively but having a large reserve is a means of making sure that we are not caught without sufficient funds to execute our plans.

ANNUAL WINE TASTING SUNDAY, JUNE 8


