DID YOU KNOW?

The County's Department of Environmental Protection (DEP) has made thermal imaging cameras available through the County's library system. If you are a Library cardholder, you can borrow the cameras to monitor energy use in your home.

The easy-to-use cameras are designed to create visual heat maps to reveal hot and cold spots via color-coded images so you can easily identify if your home is losing or gaining energy. The cameras attached directly to the battery port of iPhones or Android phones and can be checked out with a library card but you may have to wait as there are only four Android compatible FLIRbrand cameras and four iPhone compatible cameras available.

Wondering where the AC is cooling the outside? You can get a good indication with these cameras. The Chevy Chase branch is one of four libraries with these cameras.

RECORD RAINS THIS YEAR

The Washington Post has just reported that in the past 365 days, Washington has received 71.5 inches of rain and melted snow. That makes it the wettest period since they began keeping records in 1871. So if you thought you hadn't seen so much rain, you were right!

And if a lot of your events have been rained out (like our Food Truck Night), it's because 2019 ranks as the 35th wettest year on record year-to-date with a disproportionate number of rainy days between Friday and Sunday. For those of you who have new trees in the greenway in the past two years, water them as much as possible, at least twice a week if it doesn't rain so that they have the best chance to get established.

COUNCIL ACTIONS ANNUAL MEETING SHEDS NEW LIGHT ON AREA DEVELOPMENT

Master Planner Elza Hisel-McCoy detailed all the activity going on in both Chevy Chase Lake and Bethesda in the next few years. The amount of new building and the extent of that building is dramatic and a bit overwhelming. It's one thing to see it on master plans, it's another thing when you see it coming up out of the ground. Hisel-McCoy presented artist renderings of some of the many buildings going up and detailed their heights and usage.

At the business portion of the meeting, Council Chair Bill Brownlee summarized some of the many things that had taken place during the year. He recalled our cold, wet winter and some of the many challenges caused by sump pump outfall freezing, the joy of finally seeing the demolition of 3602 Taylor Street, and our many community-building social activities. Brownlee also discussed the way the Council responded to the lack of legislation to protect our community from 5G cell operators installing equipment in our community without our permission, the short term rental legislation at the County level and finally, the Accessory Dwelling Unit legislation which threatens to increase the density of our community. He turned the program over to Vice Chair Susan Manning who discussed our response to the upcoming 5G installations in greater detail as well as the short term rental program. Manning discussed the community-wide need to address stormwater management issues which continue to create problems for our community. Manning turned the program over to our Buildings and Roads Representative Carolyn Greis.

Ms. Greis then detailed some of the many building projects that property owners have undertaken this past year. She reported that a whopping forty building permits were issued this past year as compared to twenty-six last year, and that the following were built: 14 fences, 6 driveways (replacement, reconfiguration or new), 7 patios or decks, 1 exterior kitchen, 5 additions, 1 playhouse, and, once again this year, 1 pool. Five demolition permits were issued, 4 permits for the construction of new homes, 4 permits for dumpsters, and 2 permits for PODS. Finally, 8 variances were issued to residents or builders in the past year. She closed by pointing out that despite some obvious "construction fatigue,"

what makes it easier for neighbors to show patience is that we know our neighbors and we are a close-knit community.

Section 3 has so many community activities (for example, four this month: the Food Truck Night, the Shred Event, the Annual Meeting, and the House Tour) that without volunteers, these activities would not be possible. Secretary **Melissa Brown** took a moment to thank some of the many volunteers, including **Jan Augustine** who manages our website as webmaster, and **Ellen McKenney** who welcomes every new family with both wine and flowers. Two of our residents gave of their time and energy by dressing up in costumes to the delight of all our kids: **Scott Shuchart** who dressed up and led the Halloween Parade and **Ricky Mojica** who donned a bunny suit for the Easter Egg Hunt and Lunch. Oh, the things we do for our kids!

Finally, Treasurer **Mike Dietrich** went over the budget and then proposed that via ordinance, we approve the budget which mandated the same \$.02 (two cents) per \$100 assessed valuation for real property and \$.05 (five cents) per \$100 assessed valuation for personal property and utility-owned property within the Section.



The meeting adjourned with this year's volunteer registrar Kathryn Allen providing the election results: 30 votes each for Bill Brownlee and Susan Manning, and 31 votes for Carolyn Greis.

At the end of the evening, the Council took the oath of office and decided to keep the same positions

for each of the Councilmembers.

VARIANCE REQUESTS

Julia Hawley of 7105 Fulton Street is requesting the following three variances with regard to the proposed addition to her house as well as a proposed new garage on the property: the first to enclose an existing screen porch which extends 3.8' into the 8' north side setback; the second to construct a covered front porch and steps to grade which intrude 6' into the 30' front yard setback; and the third to build a garage which intrudes 15' into the 20' rear setback and 5' into the south side yard setback.

The **Wilsons** of 3704 Taylor Street are requesting a variance to add a gas-vented fireplace, the venting for which will extend a maximum of 1' into the existing 5' east side yard setback.

Throughout Ken's illness, he received countless blood transfusions from total strangers who donated their blood to help sustain him. Though his form of leukemia is rare, there are so many people with blood diseases requiring transfusions. The family felt that there is no better way to "pay it forward" than to help return the kindness by donating blood in his memory. And if blood donation is not possible, the family asks that you find another way to make another person's life a little better. Through more than four decades of writing his weekly real estate column for the Washington Post, Ken worked to help and improve the life of his readers. The family asks that you help preserve his legacy by paying it forward.
