COUNCIL DISCUSSES MAJOR BUDGET ITEMS


Section 3 residents will benefit from a series of new projects—including upgraded street lighting throughout the community—that are now under discussion by the Council.

At the most recent Council meeting, major capital improvement expenditures for public lighting were outlined, along with a project to improve street signage, lettering and posts in the village. Another project planned for the community will create a Geographic Information System (GIS) for Section 3. The system will allow the village to call up all past and present building activity connected with every lot and structure, to generate maps for contractors, locate street lights, trees, sewer inlets and other items related to our infrastructure—all on efficient, electronically generated GIS maps. Several other towns and village in the area either have installed a GIS program or are planning on doing so.

Regarding street signs, the Council last year hired a consultant to evaluate all existing signage. Based on the consultant recommendations, we have recently installed or re-installed street signs throughout the village for safety purposes (stop, no parking, bump, etc).

Our next step is to improve the actual street name signs with new and improved lettering and posts. The Council has discussed the type of signage it would like to see. A prototype order for a single intersection will soon be ordered. So before we put out for bid an order for all street signs, we can be certain that we find the new signs effective and appealing. The Town of Chevy Chase did this some years ago and its borders are clearly noted by the street signs. Section 3 is eager to improve the look of the signs with a different background and font style, but one which is more easily readable at night than the signs in the Town of Chevy Chase.

At the same time, the Council has determined that we need to better survey the community and install permanent markers at every corner in the community, that way, when a resident needs to have a boundary survey done, much of the work will have already been done and the cost for a boundary survey to the homeowner should be much lower. At the same time, it will make it possible for us to introduce a change in our ordinances such that when any addition or new construction takes place in the community, a boundary survey will be required and the data will have

COUNCIL ACTIONS

The Council met on Wednesday, February 11th at CCUMC in room 109. The meeting began at 7:55 p.m. All Council members were in attendance.

PUBLIC SAFETY ISSUES

There were no significant police reports for the last month.

Street safety signs are being installed. It was discovered that we were missing three bump signs. They were ordered and will be installed along with the other new signage. New signage should be installed within about a week to 10 days, weather permitting.

BUILDINGS AND ROADS

The two O'Brien properties are well underway. **Mr. O'Brien** will inform us when the well driller will install the geo-thermal pump at 6803 Florida Street. Otherwise, work is progressing on both houses.

There seems to be no activity on the two lots for sale on Bradley Lane. Once the weather is a bit warmer, the Village Manager promises to ask the property owner, **Patrick Strauss**, to clean up the area outside the wall which is filled with debris. We have already had our contractor clean the swale of debris when they did street cleaning.

The head of Buildings and Roads is working with the owners, neighbor and builder of the new house on Taylor Street to resolve shared driveway issues. Section 3 called in our consulting civil engineer who reviewed the drainage plans for the house and suggested a second discharge tank for the rear yard, which the builder has agreed to so that water problems will not impact on adjacent neighbors' rear yards.

The Council discussed the grass or lack thereof in the park and that we will have to overseed in the spring. Rules for dogs in the park are now posted and most people seem to be obeying them. Our irrigation contractor has noted the leak in the valve in the park and promises to repair it as soon as the weather is warm enough.

The **Barry** family's request for a variance (see February 2009 News and Views) will be voted on at the March meeting.

An educational forum has been organized by the managers of Martins Additions and Section 3 for all the Chevy Chase communities with a consulting lighting engineer to better inform us all about lighting issues. The forum's cost will be split among all the jurisdictions attending. Each jurisdiction is sending two represen-

tatives to the forum.

The Village Manager reported that Chamberlain contractors will be milling, paving and patching the no outlet segment of Delaware Street as soon as it is warm enough. All residents will have plenty of notice before the work begins but it shouldn't take more than two or three days at best for the work to be started and completed. This is one of the few streets that hasn't had any repairs in many years. In addition to milling and paving, there is a large area requiring a deep patch on that block where the underlying foundation of the street has deteriorated.

The next block that will be milled and paved will be the block of Florida Street between Spring and Raymond Streets but that won't happen until after all the construction on the new house on that block at 6803 is completed.

The Council discussed all the big-ticket items that it would be putting out for bid or exploring in the near and distant future: evaluating our lighting system, putting out for bid a package to provide us with a working GIS system and boundary markers throughout the community, new street signs for the entire community to distinguish our community and make the streetscape more attractive and unified, and possible new lighting for the community. It was agreed that for this upcoming budget, we will use some of our reserves for these long-term investments.

FINANCIAL REPORT

The Council agreed to seek out one additional bank with FDIC insurance in which to place some investment funds. It was agreed that this year's budget process is going to be challenging as we won't have a very accurate assessment of our income tax revenues because of the downturn in the economy. As always, we will budget conservatively with that in mind.

COMMUNITY AND SOCIAL



OTHER

The organizing meeting for the new Chevy Chase Seniors Village is set for February 17th, and a number of Section 3 residents have been asked to or volunteered to be involved. We will continue to report on their progress.

The Council agreed to update the website with new building permit information and a revised, updated copy of the ordinances which are now being proofread.

The meeting adjourned at 8:45 p.m.


EASTER EGG HUNT AND LUNCHEON PLANNED

STREET LIGHTING GETS A CLOSER LOOK

As of January, 2008, the type of light which illuminates all Section 3 streets—a mercury vapor model—can no longer be manufactured because of its environmental impact. Pepco has some stock of replacement lights, but ultimately, we will have to select a different kind of light to illuminate our streets. At the moment, Section 3 pays Pepco not only for the street lights (including those on Connecticut Avenue and some on Brookville Road in our Section), but we pay Pepco to maintain those lights. Almost a third of every month's Pepco bill is for "maintenance" charges. Our average Pepco bill for all street lighting (excluding the gazebo in the park) is about \$600 per month.

Until recently, we had no choice but to pay those fees. However, the state legislature recently passed a law that allows us to decide to continue that relationship with Pepco, or arrange to maintain the lights ourselves, and even to purchase and maintain our own lighting. This leaves the field wide open for many choices. Another separate option is to possibly join with other municipalities in Montgomery and Prince Georges County interested in purchasing electricity at a cheaper "co-op" rate. That consortium has yet to form, but we are being kept in the loop by the individual organizing the group.

The Council is currently exploring options for the future street lighting of our streets. Several local jurisdictions have already made the switch. The Village of Friendship heights has for many years, installed and owned their own sodium vapor lights which they pay a private contractor to maintain for them. Chevy Chase View (south of Kensington) has recently added 30 lights to their 50 light inventory and had Pepco switch the style and type of light to a less maintenance intensive but very attractive "induction" light. Garrett Park has also made dramatic changes in their lighting, not just on Strathmore Avenue (mandated in part by the State Highway Administration) but also on their interior streets. Kensington is working with a private contractor to purchase all their street lights from Pepco and shift to a different fixture and maintain their own extensive (some 300+) street lighting. Chevy Chase Village is exploring the possibility of abandoning Pepco poles entirely and installing a whole new system of street lights and poles of their own with underground wiring. As this relates to pedestrian safety, they will be able to use the revenues from their speed cameras for this purpose. Other local jurisdictions are also exploring their options.

UNDERGROUND RAILROAD IS MARCH 19 COMMUNITY LECTURE TOPIC

Historian and author Anthony Cohen, who has traced the steps of runaway slaves on the Underground Railroad, will present the Chevy Chase Historical Society's spring lecture on Thursday, March 19, at 8 p.m. at Chevy Chase Village Hall, 5906 Connecticut Avenue. The community is welcome to the free program.

"The Underground Railroad in Montgomery County History" will be the topic of Cohen's illustrated talk. Cohen describes the Underground Railroad as "...one of the most positive aspects of our heritage, although it grew out of one of the most insidious chapters in our history." He is the founder and president of The Menare Foundation, Inc., a national non-profit which offers tours of Underground Railroad landmarks in Montgomery County, a major starting point on the secret escape route for runaway slaves.

As a complement to the lecture, CCHS will offer a two-hour walking tour of Underground Railroad sites, "In Their Steps," in Rockville on Saturday, March 21. The cost is \$15 per person for CCHS members and \$20 for non-members. Detailed registration information can be found at www.chevychasehistory.org. to conform to the GIS system so that we can over time, input all property boundaries correctly and not have concerns about the accuracy of property lines between houses. The Council has already agreed to this in principle but would not like to impose the boundary survey requirement until after the monuments are in place.

None of these items is inexpensive. We asked one firm to bid on the GIS system; their bid, however, far exceeded our \$10,000 ceiling for contracts issued without bidding. We will now prepare and send out a package to three recommended bidders for this work. As part of this effort, we will also have to acquire a PC laptop exclusively for the purpose of holding the GIS system and our community database which is now operated by the Village Manager on her own software and her own machine. Consolidating these two functions will make the flow of information and tracking of jobs far more flexible and make it possible for the Council member in charge of buildings and roads to maintain records without heavy reliance on paperwork. At the moment, all the building permits ever issued since we incorporated in 1981 are bound in 10 loose-leaf notebooks, a clumsy way to maintain community records!

The next year promises to be an ambitious one, but one which will create long-lasting improvements for the community.

And while we will spend down some of our reserves for these efforts, the Council is keenly aware that our main source of funds, income taxes, may well be depressed for the next several years, so we will be prudent in our use of those reserves to be certain that we don't overspend at a time when we may have to rely on that "rainy day" money.

EDUCATIONAL FORUM ON STREET LIGHTING

Section 3 and Martins Additions were hosts to a recent educational forum on the subject with lighting consultant, Scott Watson, whose services have been used by several jurisdictions in this area.

Our street lights were probably laid out in the 1920s when much of Section 3 was developed. We have added a light here and there where dark spots have been of concern, but the entire system has never been evaluated for its effectiveness and for the best type of lighting for our streets.

The Council has agreed to the next step: hiring a consultant to review our current lighting system with an eye towards defining our needs and options. Pepco, sadly, offers a very limited series of options in terms of lighting type and styles for those who are switching from mercury vapor to other lighting systems and styles. There are many other options and we have begun the education process to better understand what makes sense in terms of quality of light, expense, duration of fixtures, etc.

The variables are endless but the goal is simple: good quality lighting for both cars and pedestrians; lighting that will not glare into bedroom windows; energy and cost efficient lighting; lighting that will provide safety for our residents without the "daylight" look of downtown commercial streets.

The Council fully expects that it will have to spend a portion of our reserves for this effort, but it is hoped that if properly executed, these improvements will last for generations and improve our safety and streetscape over the long term. As we continue the process of evaluating our needs, we will continue to keep the community informed.



BCC HONORS MONTGOMERY COUNTY TEACHER OF THE YEAR


