The Council met on Wednesday, July 11 at the Chevy Chase United Methodist Church. All Council members were present.

PUBLIC SAFETY

The Chevy Chase Police report showed minimal activity. They hope to install speed cameras in Chevy Chase Village as soon as they get State Highway permission.

The Council reviewed the Brookville Road speed camera report and was concerned over the percentage of drivers going 15-20 miles over the speed limit. Copies of the studies are available should any resident wish to review the data, it's available from the Village Manager. The Council agreed that speed cameras might change the behavior of commuters who get stung by a ticket but there would always be others traveling through for whom the cameras would also be a deterrent.

BUILDINGS AND ROADS

The Council discussed the water infiltration system being installed at the **Corbett** residence. They also discussed the new grate to be installed on the storm drain belonging to Section 3 in the McKinney's yard. The Council reviewed the water problems caused by neighbors in Section 5 flowing into the **Connor's** residence. The Village Manager is going to speak with the neighbors about coming to some sort of solution to the problem they are clearly unaware of. The Council agreed to have the soil tested to see if it percolated properly on Georgia Street near Shepherd Street for a possible infiltration system to prevent the extensive icing that has occurred in the past few winters,

The **Nott-Greis** family of 7003 Florida Street was granted a variance for a small addition on the rear of their home. The couple had previously received a variance from the county because different rules apply to houses that are "through lots"—that is homes with a rear yard on one street and a front yard on another.

The Council discussed the possibility of putting a picnic

table and benches in the park near the Gazebo.

The Council discussed the lot now for sale at the corner of Bradley Lane and Connecticut Avenue. The owners, Pat and Mary Strauss, propose subdividing it into three additional lots. No hearings have been scheduled as yet. The Planning Board does not meet in August. Paul O'Neal, Esq. of the firm of Lerch, Early & Brewer, an attorney representing an unknown client interested in the property attended the meeting but declined to reveal his employer.

The Council heard a summary of the plans to renovate the Church pre-school playground. It is anticipated that the renovation will be completed by the time the pre-school begins in early September.

FINANCIAL REPORT

The Council reviewed the financial report. The Village Manager will be working on the annual audit in August. Dennis Alexander, CPA, has been hired to do the audit.

The Council discussed the efforts to raise funds for the Rosemary Hills playground renovation and discussed the possibility of making a donation to the Chevy Chase United Methodist Church playground since Section 3 children play there so much.

COMMUNITY AND SOCIAL

The Party-in the Park is slated for September 16. It was agreed that we would hire the same caterer but search for another company to provide the rides.

The Council discussed the plans for the Welcome Neighbors Barbeque on August 9.

The meeting adjourned at 9:15 p.m.

CAR BREAK-INS IN SECTION 3

Smash and grab thieves broke into four Section 3 cars on the night of August 2. They opened an unlocked car on Delaware Street, but took nothing but then went on to break the glass on three other cars, taking a briefcase filled with credit cards on Georgia Street near Shepherd, an ipod from a car on Georgia Street near Taylor, and a backpack from a car on Florida Street between Shepherd and Taylor Streets. The contents of the backpack were later found in the park.

This kind of reckless destructive disregard for other people's property is extremely disturbing. The police were immediately notified by the homeowners and the Chevy Chase police as well. The Bethesda police detective reviewing the events urged residents to lock their cars and keep anything that might attract a thief in the car. Anyone with any information regarding suspicious persons is urged to contact the police about this matter. If you see any suspicious persons in the neighborhood, contact 911 immediately.

BUILDING PERMITS PROCESS CHANGES


Thinking about making a change in your house? Before you get very far in the planning, talk to Section 3's Buildings and Roads person, Carolyn Greis because there is a new process instituted by the County. Before you get a permit from the County, you need a letter from Section 3 saying that the Section is aware of your plans and that you can apply for a permit first from the County and then from Section 3. This gives everyone a chance to make sure that what they hope to build is in conformity with Section 3 regulations. You will still have to submit plans and get them approved first by the County and then by Section 3, but this "advance look" gives each municipality in the County a heads-up on what you're planning and an opportunity to share our regulations with you to avoid problems later.

Without a letter from the Section 3 Buildings and Roads Council member, you will not be issued a permit from the County—so check first.

CHEVY CHASE FIRE DEPARTMENT **OPEN HOUSE**




