

For those new to the neighborhood, this event started

Then some of the residents pointed out that for single, older residents, it was not so easy to prepare the food for a larger group in order to participate, and further, it wasn't so easy getting up and down from those blankets in the park—so we added tables and chairs and hired a caterer... And, then to entertain our many children, we added rides—one year a memorable hayride with enormous draft horses, another year a few rides, and finally, the event has morphed into a major event with LOTS of rides for children, great catered food, sit down dining, a cake walk, a dj, and of course, hundreds of Section 3 families all eager to catch up with one another after the summer's activities and the beginning of school.

## COUNCIL ACTIONS

The Council met on Wednesday, July 14th. All Council members, except Carolyn Greis, were in attendance. The meeting began at 7:55 p.m.

#### PUBLIC SAFETY

The Village Manager reported that she had not heard back from the coordinator at the 2nd district police department regarding our request for an off-duty officer to patrol our streets but will make another attempt. There were no responses from the FOP website announcement. A second individual who coordinates off-duty police for Montgomery County Police had some problems regarding the insurance coverage that we require and so we are now working with a third possible coordinator at the county level. This individual has already made contact with Section 5 for the same services and it appears that once contractual issues are worked out with the County attorney, the same contract will be appropriate for Section 3 as well.

We have received approval for funding for the second snowstorm from FEMA and should be receiving a check within the next five or six months.

# NEW DIRECTORY IN THE WORKS

Take a good look at your listing in the current Section 3 directory. Make sure to let us know about any errors, additions (new babies) or changes in email that you'd like to make. #### BUILDINGS AND ROADS

The Mostofis at 7001 Georgia Street received a fence permit and are busy building an impressive fence. The property at 7104 Fulton Street is moving into the final stages of completion and the Buildings and Roads representative and the Village Manager have been working with the foreman coordinating the job.

A building permit was issued and construction begun on the first of two lots at Connecticut Avenue and Bradley Lane. A permit was also issued to reface the existing wall that surrounds both parcels. Marc Weller is the contractor on the job and has been working with the Buildings and Roads representative and the Village Manager.

Aly Tareq, the owner of 3600 Taylor Street, has received a permit to build a deck that is now complete; it was built within compliance. The property is now on the market.

Milling and paving on Florida Street was completed without too much disruption. D & F Construction did the concrete work. A.B. Viers did the milling and paving. FSM did the stop bars.

#### LEGAL ISSUES

The Council agreed to hire David Podolsky to represent the concerns of the community regarding the proposed Edelen daycare center. The next hearing before the OZAH was slated for August 23 but was postponed by the hearing examiner because of a backlog of work. The new hearing date will be in Rockville on October 1st. Interested residents should contact the Village manager for details as to time and place.

#### FINANCIAL STATUS

The Council went over the CDs maturing in August and agreed to find the highest possible interest rate for everything from 9 months to 18 months.

#### COMMUNITY AND SOCIAL

All the contractors have been hired for the Welcome New Neighbors' Event...and fans will be used this year because of the heat.

# EDELEN DAYCARE CENTER APPLICATION SCHEDULED FOR OCTOBER 1 HEARING

Despite the concerns presented by Section 3 regarding the impact on traffic and the community, including the thorough traffic study we commissioned, the Park and Planning Commission voted 3 to 1 on July 1 to recommend that the expansion of the Edelen daycare center be approved as long as they made alterations to the driveway to accommodate ADA regulations. The Commission also recommended that if the hearing examiner approved the plan, it would be reviewed after nine months of operation to assess whether it was causing traffic problems. However, they did not indicate what remedy was available if that finding occurred). The plan, as approved, calls for 9 children to arrive between 7:45 and 8:30 p.m., another 9 children between 8:30 and 9:15, and another 6 children, who will only attend for a half day, to arrive between 9:15 p.m. and 10:00 a.m. As we indicated in our testimony before the Commission, we are concerned that these arrival time windows, as well as pick up times, may not be strictly implemented in a way that will minimize the traffic safety concerns cited in our traffic study.

Testifying before the Commission against the proposed application were our traffic consultant Joe Cutro, Council Chairman Bill Brownlee, developer Marc Weller who is developing the two adjacent lots, Pat Burda representing the Town of Chevy Chase, Lanny Johnson, another adjacent neighbor, Bob Salmon, former Council chairman and a Raymond Street resident, and Andy Leon Harney, the Village Manager.

The next hearing is slated for the morning of October 1st before the OZAH hearing examiner. Anyone interested in attending this hearing should contact the Village Manager to get details on the location, etc.

### CCUMC BLESSING OF THE ANIMALS, SATURDAY, OCTOBER 9TH

## PROPERTY TAX BILLS: SECTION 3 RESIDENTS DO NOT PAY SOLID WASTE CHARGE

If you've already paid your tax bill, and you paid for the entire year at once, then you may want to ask for a refund of \$41.43, the solid waste charge that Section 3 pays for all residents living in Section 3. If you make two payments, then the County will make the adjustment on your second bill. Every year the County provides us with a listing of all residents and we pay for every owner occupant in Section 3 in a lump sum. Unfortunately, the bills have already been sent out by the time they get us our invoice, so the only way to adjust for this problem is to notify you directly. Several years ago the Council decided to cover this charge with the funds collected from our property taxes. This particular charge, along with the water quality protection charge are NOT deductible..

# HEAVY RAIN STORMS LEAVE SOME IN SECTION 3 POWERLESS

The most recent rain storms left 8 Section 3 residents without power for 5 days! Two transformers blew and it took Pepco to the final day they promised to have everyone back on line to get to these hot, unhappy homeowners. One thing that everyone with FIOS discovered in this last series of outages, if you have phone service via FIOS as opposed to the "old fashioned" land lines, you didn't have phone service for long, as the batteries, said to last 12 hours, lasted for much less time in most instances. Those with cell phones spent some time running to neighbors or their cars to recharge their phones and those with land lines suffered no hardship in communicating with others even if they were without power.


