STORM DRAIN REPLACEMENT COMPLETE

Diligent work during a heat wave at the end of July gave us the first new storm drain in over 20 years. Residents may recall the sinkhole which appeared on Shepherd Street a year ago last May. While emergency repairs were done to the sinkhole, it took some time to identify the cause and even more time to find funding within the County's budget. Montgomery County is responsible for maintaining our storm drain system. It was determined that the 10-inch antique terra cotta pipe had simply collapsed, allowing all the stormwater runoff that entered the inlet at Shepherd Street and Delaware Street to flow under our sidewalk, under our street until the system was repaired. Happily, the County uses the same contractor Section 3 has used in the past, D&F Construction. Despite record high temperatures, the new 15-inch reinforced concrete pipe was threaded through gas, water and sewer lines leading to neighboring homes on the north side of the street with minimal disruption. All those homeowners have new sidewalks, new driveway aprons.

We are grateful to the County in finding the extra funds to pay for this ambitious project. In the fall, new street trees will be planted to finish the job. We also appreciate the patience and understanding shown by neighbors on the block of Shepherd Street between Delaware and Fulton Streets who were often prevented from using their own driveways. Your cooperation was invaluable.

The Council met on Wednesday, July 13, 2016 in Room 107 of the Chevy Chase United Methodist Church. All Council members were in attendance with the exception of Natasha Saifee who was out of town. The meeting began at 8:00 p.m.

The minutes of the June meeting, as published in the July newsletter were approved.

POLICE REPORT

The rotating policemen seem to be doing a good job of monitoring stop sign compliance and patrolling the neighborhood.

Buildings & Roads

Buildings and Road representative Carolyn Greis reported that the **Connor** family of Georgia Street has been issued a building permit for the addition and remodeling of their home. The Council voted to allow a variance to the **Carstens-Trenor** family of Florida Street to make a portion of their now pervious driveway impervious so as to alleviate a flooding problem in their garage (see *News & Views* Council Actions June, 2016).

The Village Manager reported that D & F Construction hopes to start work on the storm drain replacement on Shepherd St. between Florida and Delaware Streets by mid-July. We don't have a firm date as yet. It has been decided to use the dead end of Delaware Street as a staging area for the equipment and porta-potty.

The road improvement bid package should go out shortly, final revisions are being made. It's likely that the work will not be done before school begins. Happily the work on Raymond Street should not take that long but the work on Delaware Street may take longer.

The Council agreed to have the Village Manager and the head of Buildings and Roads to review the bids and make a decision as to the winning bid as the Council doesn't meet in August and the Council Chair will be away.

FINANCIAL REPORT

The Council agreed to hire Dennis Alexander, CPA to conduct the state-mandated annual audit of our books.

Mr. Alexander prepared charts showing the differences year-to-year in our income tax revenues which cannot be explained. The Council agreed to continue to seek information on the audit done at the State Comptroller's office and also arrange for an appointment with the State Comptroller to discuss our concerns.

We have a CD coming due in August with Rosedale Federal

Savings and Loan and we need to find another institution to move our funds out of Monument Bank by November because it has been purchased by Revere Bank with whom we already have accounts. If we left our money in Monument, we would be over the FDIC insured limit.

COMMUNITY & SOCIAL

Lots of new neighbors moving into the neighborhood, all have been invited to the Welcome New Neighbors Event on Thursday, July 14. The Council members divided up bartending duties for the event. The Council reviewed wine tasting event, the food truck night and the community wide yard sale.

The Party in the Park date is set for September 18 with a rain date of the 25th.

OTHER

The new website is up and running with all our policies, all our newsletters and current information readily available. We will continue to add to and refine the site but the new site is finally up although initially it was impossible to fully see from a mobile phone. That has since been corrected.

The meeting adjourned at about 9: 00 p.m.

BROOKVILLE AND TAYLOR STREET INTERSECTION TO BE IMPROVED

After almost four years of work with the State Highway Department and a little endorsement from our Montgomery County delegation to the State, SHA has designed a new, safer intersection at Brookville Road and Bradley Lane. It's hoped that construction will start this fall to make it safer for pedestrians and easier for drivers to spot the stop signs.



NEIGHBORHOOD NEWS

It is with sadness that we report the passing of a long-time Section 3 resident, **Helen Metcalf**, who lived in her Raymond Street home with husband John and family for over 40 years.

VARIANCE APPLICATIONS

The Council will hear three variance requests at their meeting in September.

The **Manning** family at 7005 Florida Street requests a variance to construct a code-required egress window as part of a larger house renovation they are undertaking. The window well will intrude 3' into the 10' south side setback.

The **Carroll** family at 3806 Shepherd Street is requesting two variances: one to build a landing/stoop with steps to grade that will extend 3'-8" into the 10' west side setback, and the second to build two low walls creating an alcove for trash cans that is located fully within the 20 foot rear setback and running along a shared property line.

Albemable Realty, LLC, the new owner of **3617 Taylor Street**, is planning on remodeling and building an addition to the house, and as part of that project is requesting a variance to construct a covered entry with steps to grade (at the location of the existing front stoop) which will extend a maximum of seven feet into the 30 foot front yard setback.

BRADLEY LANE GAS LINES UPGRADED IN OCTOBER

Residents of Bradley Lane will be getting new "high pressure" gas lines this fall. Three homes will be having the service to their home replaced as well. As soon as we have a definitive schedule, we will be notifying residents. This is such a massive job, for both sides of the street, that more than likely Bradley will be closed to through traffic while they dig ditches in the street. This means that there will be more traffic traveling on Raymond Street during that period no doubt. We will give the entire community as much notice as possible as this is a necessary upgrade.

BCC RESCUE SQUAD LAUNCHES DOOR-TO-DOOR CAMPAIGN SEPTEMBER 6



NEWS ON THE PLANNING FRONT

CHEVY CHASE LAKE

Despite the delays in the final approvals for the Purple Line, Chevy Chase Land Company has presented its plans for approval to the Planning Board for the first phase of construction which would start at the earliest, in the fall of 2018. Construction of luxury townhouses on Chevy Chase Like Drive has already begun as has construction of the Housing Opportunities Commission 200-unit building nearby.


The plans call for a roadway which will connect Chevy Chase Lake Drive to Manor Road, parallel to Connecticut Avenue and through the new development. For those of you who use T.W. Perry, they have relocated to larger quarters on nearby Brookville Road in Silver Spring. Lemon Twist, the dry cleaner and Chevy Chase Supermarket will remain open. The delay in the Purple Line due to recent court challenges may push back the start date for this development.

Sadly the plan calls for minimal green open space, perhaps a quarter acre of actual grass and trees around which 521 residential units will cluster. There will be some additional green open space for one of the apartments but that will not be open to the public in the way that the "commons" area facing Connecticut Avenue was envisioned in the original plan. The remainder of the open space facing Connecticut Avenue will be hardscaped.

DOWNTOWN BETHESDA

The Master Plan for Bethesda is in its final stages before going to the County Council this fall; however several proposed Zoning Text Amendments may alter the plans. There are very few densities in the plan, there are new heights but every property will retain its density from the 1994 plan and can either develop within that density or acquire additional densities via several means. There is an absolute cap on density of about four million square feet more than in the old Bethesda master plan which is far less than the nearly eight million total the Planning Board was approving when it was dealing with the area on a property by property basis. There is also a 15 percent affordable housing requirement for the downtown area, and stronger environmental and energy standards along with a commitment to green space including a way to build a fund to purchase properties for green space. The plan is still being refined and will be presented in its Planning Board approved form to the County Council sometime this fall.

SHORT TERM RENTAL BILL STILL IN FLUX




anywhere in the County. Yet reports have it that hundreds of residents now offer short-term rentals. Concerns about parking, owner liability, neighborhoods being converted to an overabundance of rooming houses, etc. have put a temporary pause on plans. Since the February hearing, the Planning Board has held a hearing in which Chairman Casey Anderson indicated support of such legislation. The staff of the Planning Board held an informational session in which only representatives of the short term rental industry were asked to speak. Even the hotel industry was not invited to make a presentation. Again, there was a great deal of public skepticism and tales of comings and goings in certain down-county neighborhoods. Hosts from Airbnb offerings also made the case that in their homes, such problems never occur. A second informational session will be held at the Planning Board on September 19 in which the hotel industry will speak along with representatives of the County who would be responsible for enforcing any regulations that might be established with a newer, hopefully less permissive change in the law and the zoning. Single family neighborhoods closer in run the risk of large numbers of strangers coming and going in our community with little if any regulatory oversight if this law is allowed to stand as currently proposed. We will continue to monitor this situation and keep residents abreast of the progress of this proposed change.
